Product description

"A-60 Bulkhead, Aluminium"

Composed of aluminium bulkhead insulated on both sides with minimum 2 layers of 30 mm insulation of type 'SeaRox SL 620' with density 100 kg/m³ (manufactured by Rockwool) on stiffeners side, between stiffeners and upon stiffeners.

The bulkhead insulation is mounted with standard 3 mm steel pins and 38 mm steel clips (spring washers) at intervals of approximately 300 mm / 400 mm.

Application/Limitation

Approved for use as a vertical fire retarding division of class A-60.

General application: Fire against either side.

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the MED Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.

Each product is to be supplied with its manual for installation and maintenance.
