Product description

"A-60 Deck, Aluminium"

Composed of Aluminium deck insulated with minimum 2 x 30 mm of SeaRox SL 620 insulation of density 100 kg/m³, manufactured by Rockwool, between stiffeners and upon stiffeners.

The deck insulation is mounted with standard 3 mm steel pins and 38 mm steel clips (spring washers) at intervals of approximately 300 mm / 400 mm.

Application/Limitation

Approved for use as a horizontal fire retarding division of class A-60.

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.

Each product is to be supplied with its manual for installation and maintenance.
