## **Product description**

"Aluminium Deck A60 with SeaRox FM 6040 ALU"

Composed of structural aluminium deck insulated on the underside with two layers of 35 mm thick mineral wool of type 'SeaRox FM 6040 ALU' (manufactured by Rockwool with density 60 kg/m³) between the stiffeners following their contours. The cavity of the stiffeners is empty.

The deck insulation is held in place using 3 mm steel pins with Ø38 mm steel washers welded with max. c/c 300 mm.

For further details see drawing listed under Type Examination documentation.

# Application/Limitation

Approved for use as a horizontal fire retarding division of class A-60.

The insulation materials and adhesives used have to be approved in accordance with the Marine Equipment Regulations and bear the UK Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.

Each product is to be supplied with its manual for installation and maintenance.
